### **Sub: Engagement of Technical Consultant for Field Evaluation and Advisory Services in Immature Rubber Areas – Reg.**

- Conduct periodic visits to assigned estates.
- Evaluate field conditions and growth performance of rubber plants.
- Submit estate-wise visit reports.
- Identify deficiencies and recommend remedial measures.
- Provide on-the-job guidance and training to field staff.
- Liaise with Estate Managers and Senior Officers regarding follow-up actions.

#### **3. Eligibility Criteria:**

- Minimum 15 years of experience in Rubber Plantation/Field Operations.
- Retired officers from Rubber Board/Plantation Companies/Agricultural departments preferred.
- Age below 65 years.
- Must be physically fit and willing to travel to various estates.

#### **4. Period of Engagement:**

- Initial contract will be for **one year**, which may be extended subject to requirement and performance.
