1. E-Tenders/Sealed Tenders are invited for the supply of **LOW DENSITY POLYTHENE FILM(45CM WIDTH) 30.752MT (Approximate)** as per the following specifications: **Low Density Polythene Film with 45 cm width: 30752 Kg (3844 Rolls(Approximate))**:Roll Length: 250 mtr., width :45cm, Thickness: 300gauge, Tolerance:±7%, Weight: 8Kg without core if any.
2. Interested party can participate in the tender either through e- tender portal (<http://etenders.kerala.gov.in>)or physically submit sealed tender which should be accompanied by an EMD amountequivalentto 1% of the total cost of the material as Demand Draft drawn in favour of PCK Limited, Kottayam.
3. The material should be delivered at the following destinations within the time specified in the purchase order:

4. The offered item should have satisfactory technical specifications mentioned in the schedule and the tender condition. This should be certified by Rubber Board/Other Government approved Laboratory and the copy of certificate should be submitted along with e- tender/sealed tender.
5. Conditions other than what are mentioned in the tender conditions published by the corporation are not binding / acceptable.
6. The parties who have participated through e-tender will have the facility to participate in the e-auction also.
7. The L1 party will be selected only after qualifying the sample testing procedures and based on the price quoted by the tenderer who have participated in e-tender (after e-auction) and sealed tender. The acceptance of the tender rests with the Managing Director who does not bind himself to accept the lowest rate or any other rate. The Corporation will have the discretion to distribute the quantity among two or more suppliers, if so found necessary.
8. The selected party has to remit Security Deposit of 5% of total value of material including EMD amount which will be returned to the party without interest after satisfactory completion of the contract.
9. The Supplier shall not assign, make over, underlet or sublet the Contract to any person or firm.
10. PCK management will have the right to accept or reject any tender without assigning any reasons and decisions of the management will be final. The successful bidder will be given a Purchase Order after which an agreement should be executed with the Corporation in the prescribed format in Kerala Stamp Paper worth Rs.200/- for the due fulfillment of the contract in the aforesaid conditions after remitting security deposit mentioned above.
11. The quantity mentioned in the schedule is only approximate and the successful bidder will have to supply the entire quantity at the agreed rate at the respective destinations mentioned in the Purchase Orders within the period stipulated therein.
12. If the selected party fails to supply the offered quantity or supplies materials that do not conform to the requirement of the Corporation/withdraws from their offer before the expiry period of supply, the Corporation shall have the liberty to cancel the agreement and to forfeit the security deposit and also to arrange purchase of the items not supplied as a whole or part thereof at any rate from anywhere else and the resultant losses and expenses incurred on this account will be realized from the tenderer and Corporation has authority to blacklist the defaulting tenderer from participating in future e tenders. In case of delayed supply if any, penalty at the rate of ½%

of the cost of the material to be supplied will be realized for every seven days or part thereof upto a period of one month maximum. Even after the extension period, if the tenderer fails to complete the supply, Corporation is at liberty to cancel the agreement and also to take further action as mentioned above.

13. The following certificate is to be furnished in the invoices.

14. The Corporation has the right to extend the date of bid submission before opening the tender if there is lack of sufficient number of participants in the tender. In such cases the tenders already received will be kept in safe custody which will be opened along with any new tenders received at the end of the extended period.
15. 50% of the cost of the material delivered to each estate will be effected after getting SR Note and Invoice from the concerned units. Balance 50% will be effected immediately after getting the weight list, Satisfactory, Test report of the samples etc. from the concerned estate.
16. In case any difference or dispute arises in connection with the contract, all legal proceedings relating to the matter shall be instituted in the Courts having jurisdiction at Kottayam only.
17. The cost of tender form is **Rs.7552/-** including 18% GST should be paid through online for those who apply through e- tender and for physical sealed tender the amount can pay at our office or through DD/RTGS in favour of PCK payable at Kottayam.
18. If the tender is not conducted on a particular day published in the tender notice due to Strike/Hartal/Holiday, the same tender will be conducted on the next working day without any changes in the time and venue.
19. If the tenderer participates both in e- tender and sealed tender, the lowest rate quoted among the two tenders will be considered as L1 (after evaluating the quality of the material by Rubber Board/technical committee). Successful bidders will be identified based on the satisfactory quality test report of the samples and the rate quoted by the party.
20. The last date and time of submission of the bid through online/Sealed tender is at **on 11.30AM, 30.12.2025**
21. In addition to other technical parameters, those who participated through e-tender and qualified in quality testing procedure will be allowed to participate in the e-auction (Reverse auction). The date and time of E- auction will intimate later to the qualified bidders through the e-tender portal/Corporation. The eligible bidders will receive the e-auction notification through e mail and SMS on the mobile number registered in the portal once the schedule is published. Bidder's representatives are welcome to be present at the opening of the e-tenders and after completion of the e-auction. In case if tender date is extended due to lack of sufficient participants, date of e- auction will also be extended accordingly.
22. In the case of sealed tender, Bidders has to be submitted their bids in two separate Sealed covers. **Cover (1)-Documents Cover-** Should be included tender documents such as signed copy of tender condition, test result, original demand draft of EMD amount and other relevant documents. **Cover(2)- Price bid portion-** Price of the material should

included in this cover in sealed envelope . Cover (2 -Price bid Portion) received from the parties will kept under safe custody until e-auction is completed and the date& venue of opening of both tenders will be intimated to the parties later.

23. Those who are participating through sealed tender should clearly mentioned detailed postal address with Telephone/Mobile No and email id over the envelope for further intimation to the party regarding opening of tenders.

Tender should accompany the following:

- i. **In the case of E-tender:** EMD as Demand Draft along with duly signed tender document is to be scanned & uploaded in the **e-tender site** on or before **on 11.30, 30.12.2025**.The Signed Tender conditions in original (**without Price Bid Portion**) along with original Demand Draft of EMD and Samples with test report of the materials from Rubber Board/Government Recognized laboratory should be given in sealed cover superscripting **“E-Tender for the supply of Low Density Polythene Film for 2026-27 season”** to reach the Managing Director, Plantation Corporation of Kerala Ltd., Kottayam- 686 004 on or before **on 5PM, 30.12.2025**.
- ii. **In the case of Sealed tender:** Sealed Tender has to be submitted as **twoCover-Cover(1)Documents portion** including EMD as Demand Draft, signed tender documents along with the sample test report of the materials from Rubber Board/Government Recognized laboratory should be given in sealed cover superscripting **“Tender Documents for the supply of Low Density Polythene Film for 2026-27 season”**. In cover (2) Price bid portion including offer showing the rate for the supply of material (**Price Bid**) should be given in sealed cover superscripting **“Price Bid for the supply of Low Density Polythene Film for 2026-27 season”**.

RAINGUARDING MATERIALS: (Low Density Polythene Film)

1. The Polythene Film supplied should be LDPE. The supply should be in Rolls of 250Mtrs. and should conform to the following specifications:
 - Length - 250 Mtrs.
 - Width - 45 Cms.
 - Thickness - 300 Gauge
 - Weight - 8.000 Kgs. (without core if any)
2. The Film should be made out of fresh Virgin, Low Density Polythene Granules and also should conform to satisfactory manufacturing standard and workmanship. It should be free from cuts, lines opaqueness, foreign materials etc. and also free from other defects.
3. A tolerance of plus or minus 7% will however, be allowed in gauge.
4. The approximate quantity required is 3844Rolls (30752Kgs approximate) is to be supplied to the following estates:

5. **The quantity shown above are only approximate. The exact quantity will be intimated in the Purchase Order and the supplier is liable to supply the material as per the Purchase Order.**
6. Entire quantity [Full quantity] should be supplied within the time stipulated in the Purchase Order.
7. A specimen sample not less than 4Mtrs in Length having the Gauge and width should be attached along with the tender with test result from a recognized lab. The required No. of sample Rolls of Polythene film should be given to the Head Office for sending the same to the concerned estates for verification with the bulk supply.
8. Samples will be collected at random from 3% of the total No. of Rolls supplied to each estate. This will be tested at an outside testing facility to ensure the quality. The samples will be collected by the concerned Estate Managers. The supplier or his representative will be given opportunity to be present while taking samples. Corporation will have the discretion to distribute the total quantity to two or more Firm, if so found necessary.
9. 50% of the cost of the material will be effected after getting the SR Notes from the estates confirming the verifiable physical attributes of the material. Balance 50% payment will be made after getting the satisfactory test report of the random samples.
10. The rate per Kg. of Polythene film should be quoted in the BOQ (Including GST & Other Charges).
