1. The vehicle can be inspected during working hours at the above place with the permission of the concerned authorities.
2. An EMD of Rs.5000/- in the form of Demand Draft drawn in favor of the Plantation Corporation of Kerala Ltd., payable at Kottayam should be attached with the offer. NEFT/RTGS transfer from the bidder bank account will also be accepted. Offers without DD/RTGS /NEFT transfer will not be accepted.
3. The offer should be exclusive of GST. Applicable GST and any other applicable taxes also will be collected extra.
4. The highest offer received in the auction /tender will be considered. The employees /workers of the Corporation are not eligible to participate in the tender/auction.
5. The highest bidder will have to remit 50% of the total bid amount immediately after the tender cum auction through bank transfer/DD. If the highest bidder fails to remit the same, his EMD is liable to be forfeited and the Corporation has the liberty to cancel the tender and conduct re tender for the sale of the vehicle at the risk and cost of the tenderer.
6. The Managing Director of the Corporation will have absolute discretion to accept or reject any offer including the highest offer without assigning any reason.
7. The successful bidder will have to take delivery of the vehicle from the above place within 15 days on receipt of tender confirmation after remitting the balance value of the vehicle with applicable GST and any other taxes as per rules.
8. The tenderer shall transfer the ownership of the vehicle within the stipulated time, failing which the corporation shall have the liberty to arrange resale of the vehicle at the risk and cost of the tenderer and all the amount already remitted by the tenderer will be forfeited.

10. The duly signed tender document should be submitted to The Managing Director, The Plantation Corporation of Kerala Limited, HeadOffice(Engineering Section), Kottayam before 3.00 Pm on 10.12.2025. The tender will be opened at 3.00 Pm at Head Office in the presence of available bidders.
11. If the tender could not be conducted on the above date due to reasons beyond the control of the Corporation, the tender will be conducted at the same time and place on the next working day. The EMD remitted is liable to be forfeited in case of any violation of the tender conditions.
12. All suits or other legal proceedings in connection with any matter relating to this tender shall be under the jurisdiction of Civil Courts at Kottayam only.
13. As a token of acceptance of the conditions mentioned above, a copy of the tender conditions should be duly signed in each page and attached with the tender.
14. Vehicle will be delivered after the remittance of full amount with applicable tax and after changing the ownership of the vehicle from PCK to the highest bidder.
15. The Insurance Policy should be transferred in the name of buyer and remove the name of PCK from policy records.
