2. An EMD of minimum 2.5% of Quoted Rate for the vehicle in the form of Demand Draft drawn in favor of the Plantation Corporation of Kerala Ltd., payable at **Kallala Factory** should be attached with the offer or NEFT/RTGS transfer will be accepted. Offers without DD /RTGS /NEFT transfer will not be accepted.
3. The offer should be exclusive of GST. Applicable GST and any other taxes will be collected extra.
4. The offer will be considered based on the highest rate both in the auction and tender. The employees /workers of the Corporation are not eligible to participate in the tender/auction.
5. The highest bidder will have to remit 50% of the total bid amount immediately after the tender cum auction. If the highest bidder fails to remit the same, his EMD is liable forfeited failing which the Corporation will be at liberty to conduct re tender for the sale of the vehicle at the risk and cost of the tenderer.
6. The Managing Director of the Corporation will have the absolute discretion to accept or reject any offer including the highest offer without assigning any reason.

The successful bidder will have to take delivery of the vehicle from the above place immediately on receipt of tender confirmation after remitting the balance value with applicable GST and any other taxes as per rules and after transferring the ownership of the vehicle to highest bidder, failing which the Corporation will be at liberty to arrange resale of the vehicle at the risk and cost of the tenderer and all the amounts already remitted by him will be forfeited.
